**2019** Arizona Form 140A Resident Personal Income Tax Booklet

**Who can use Arizona Form 140A?**

- You can use Form 140A to file for 2019 if all of the following apply to you:
  - You and your spouse if married filing a joint return, are full-year residents of Arizona.
  - Your Arizona taxable income is less than \$50,000.
  - You are not making any adjustments to income.
  - You do not itemize deductions.
  - You are not claiming any credits other than the family income tax credit, the property tax credit or the credit for increased expense taxes.
- If you are an active-duty member of the U.S. Armed Forces, you may subtract all active-duty military pay included in your federal adjusted gross income. To take this deduction you must file your 2019 return using Form 140.

**Do not file Form 140A if you are an active-duty member of the U.S. Armed Forces.**

In the federal tax law during the prior year, there were some legislative changes to the federal deduction provisions for your federal tax return. Also, the amount of federal tax changes made after January 1, 2018. If you use the federal tax credit deduction you will be required to use the federal tax credit for the amount of the federal tax credit. ## Case Study:

Organization: Hickman's Family Farms



**Challenge:** After years in development, the engineers at the Southwest's largest egg producer had finally created a new design for egg cartons. This new clear design, made from recycled plastic, helped reduce waste created when customers broke eggs while opening cartons to examine the eggs. The clear recycled and recyclable-plastic packages promised to change the egg carton forever. The challenge to Hickman's was to find a reliable, cost efficient and local source for the labels that are inserted into their plastic cartons.

**Solution:** ACI Print Shop managers met with the Hickman's team to find ways to produce the 30 different carton labels. New printing equipment was identified and procured for this specialty print job. Not long after identifying the process and making refinements, the ACI Print Shop began printing and die cutting Hickman's Family Farms labels for their new carton design. This made it possible for the entire packaging process to be done locally, cost effectively and expeditiously. Currently more than a million labels are produced weekly.

## Case Study:

Organization: Arizona Department of Economic Security, (DES), Unemployment Office



**Challenge:** With sudden upsurge in workers filing for unemployment insurance at the start of the COVID-19 crisis, the Arizona Department of Economic Security (DES) quickly needed to get supplies of their Unemployment Filing Instructions booklet into their offices throughout the state.

**Solution:** The ACI Print Shop, located within the ASPC-Perryville Women's Prison complex, had been printing the brochures for years. But with near full employment for the last few years there was little need for them. Fortunately, the Print Shop still had the digital files (InDesign) for the brochure and was able to quickly make updates to it with instructions from the DES representative. Within hours, the first batch of updated Unemployment Filing Instructions booklets was rolling off the presses. By the end of the week, state employment offices started to get supplies of this important 24-page, 5" x 7" booklet. Within just a couple months' time more than 500,000 copies were produced and delivered.
